

ORDINANCE 13-14-07

**AN ORDINANCE OF THE WARRENVILLE PUBLIC LIBRARY DISTRICT
DUPAGE COUNTY, ILLINOIS
AMENDING BUDGET AND APPROPRIATION
ORDINANCE FOR THE FISCAL YEAR 2013-2014**

WHEREAS, The Board of Library Trustees of the Warrenville Public Library District, DuPage County, Illinois (“Trustees”), by Ordinance #13-14-03, adopted a combined Annual Budget And Appropriation Ordinance for the fiscal year beginning July 1, 2013 and ending June 30, 2014; and

WHEREAS, during the course of said fiscal year the Trustees have reconsidered the amount budgeted and appropriated for certain line items in said Ordinance; and

WHEREAS, the Illinois Public Library District Act permits amendments to the Budget And Appropriation Ordinance; and

WHEREAS, the Trustees have determined that said Budget And Appropriation Ordinance should be amended in accordance with the fiscal needs of the Library District.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF LIBRARY TRUSTEES OF THE WARRENVILLE PUBLIC LIBRARY DISTRICT, DUPAGE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1. Ordinance #13-14-03 (the Annual Budget And Appropriation Ordinance for the fiscal year 2013-2014) be and is amended in the following respects:

- A.** Line item for Equipment-Purchases is increased from \$10,000 to \$22,000;
- B.** Line item for Personnel Development-Trustees-Dues is increased from \$1,000 to \$1,500;
- C.** Line item for Salaries-Technical Services is decreased from \$170,000 to \$157,500;

SECTION 2. All portions of the Annual Budget And Appropriation Ordinance inconsistent with the foregoing are amended in the same manner and to the same extent.

SECTION 3. The foregoing adjustments to line items do not affect the total amount appropriated.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


